between the Northern BC Archives & Special Collections, Geoffrey R. Weller Library of the University of Northern British Columbia ("NBCA") and the individual or organization named below ("User")

NBCA will arrange for reproductions ("**Reproductions**") of archival materials ("**Materials**") under the following conditions. Please fill out the agreement below at the time of placing the order. By signing this Agreement the User agrees to the conditions outlined below.

## **Conditions of Reproduction**

- Reproductions will be handled through the NBCA at the advertised rate of the service provider. Additional charges for handling & shipping may apply.
- Reproduction may be refused due to donor restriction or copyright law violation or due to fragility of the material.
- If a master copy is created, this copy remains the property of and in the custody of NBCA.
- NBCA makes no representations or warranties regarding the origin, authenticity, authorship, or ownership of Materials and the User assumes full responsibility for any infringement of copyright and for publication rights of Reproductions.
- User may not further duplicate reproductions for sale, or for subsequent use, without written agreement with NBCA and the payment of any applicable fees.
- Unless authorized in writing by the NBCA, and noted in the credit line, the User may not alter a Reproduction in any way (including, without limitation, colouring, transposing, superimposing or cropping) that results in significant changes to Material or to its meaning or context, or in any way that compromises the Material's authenticity.

## **Commercial Use of Reproductions**

The User may not use Reproductions for any commercial use other than with the permission of NBCA and subject to payment of a User fee per image. Commercial use includes publishing, webpage design, video production, broadcasting, self copy, exhibits, product presentations, interior design, advertising, or similar commercial use, including for-profit work done by consultants or commercial design firms on behalf of government agencies or non-profit institutions. Reproductions are provided for one-time use only. It is strictly prohibited to reproduce, resell or lend the reproduction, or to deposit it with another individual or repository. Any modification, translation or reformatting that alters the meaning or context of the material or compromises its authenticity is also strictly prohibited.
